

Thank you for purchasing SEVENSTAX GreenShark Solution Version 1.2.
Please read this document carefully and consider the Registration Process before starting the installer.
By starting the registration process you are agreeing to the End User License Agreement described below.

System Requirements

- Wireshark Version: 3.2.x
- Operating System: Microsoft Windows 10, 64 Bit

Registration Process

For the use of the Software a Registration at SEVENSTAX is necessary.

Please send an email to registration@sevenstax.de containing the following information:

- first name
- last name
- email address
- organisation name
- distributors name (where you purchased GreenShark)
- GreenShark version

You will then be provided with a serial key needed to finalize the installation process.

End User License Agreement

With this file you receive a copy of the SEVENSTAX GreenShark environment.

It encapsulates different software modules which are licensed under different license models.

1) The SEVENSTAX V2G parser ("v2gparser.exe") is licensed commercially under a proprietary license from SEVENSTAX called "SEVENSTAX Single Workstation License" obtaining the following Rights of use:

(a) SEVENSTAX grants you, upon payment of the agreed one-time fee, a permanent, spatially unlimited and non-exclusive right to use the software.

(b) Test versions: if you have installed a test or evaluation version of one of SEVENSTAX products, the right of use will be, according to the program, for a limited time only and/or technically restricted.

(c) One copy of the software is entitled to be used on a maximum of one (1) output device/workstation simultaneously.

(d) Any use beyond that agreed in this license agreement is one in violation of this agreement. In such a case, you are required to report this use that exceeds the rights of use to the supplier without any delay. The parties will then try to bring about an agreement for extending the rights of use. For the duration of the excessive usage, i.e., until the conclusion of such an agreement or the cessation of the excessive usage, you are required to pay compensation for this excessive usage according to the amount indicated in our price lists. The amount of compensation will be calculated on the basis of a four year, straight-line depreciation. If we are not informed of the excessive usage, a contract penalty in the amount three times the price of the usage indicated in the price list will be due SEVENSTAX.

(e) You are entitled to create a backup copy of the software and to conduct ordinary data backups. The creation of more copies than the amount needed for the backing up of any future usage (including the backup copies and data backups) is not allowed.

(f) Copyrights and other trademarks within the software may not be altered or removed. They must be transferred onto every copy of the software.

(g) Unauthorized transfer: only when you have purchased the software with an accompanying physical data storage you are permitted to transfer it and then, only under the following conditions: a resale of the software is only permitted when it involves an entire software copy, i.e., by surrendering your own usage of the purchased copy, you are entitled to transfer these rights of use of the physical data storage onto a third party according to the terms of this license agreement. When making such a transfer, you are required to delete the software from any storage volumes (e.g. hard disks, backups) remaining in your possession.

(h) Unauthorized rental and service: The purchase of this contract does not entitle you to any public transfer or rental of the software. You are also not entitled to include the software as part of your providing services for and in the presence of any third parties. You may purchase an appropriate license from SEVENSTAX for doing this.

2) The Wireshark plugin libraries ("secddp.dll", "v2gtp.dll", "v2gmsg.dll") are licensed under the GNU General Public License version 2.

3) The helper tool `gspawn-win64-helper` was compiled with the GLib library. GLib provides the core application building blocks for libraries and applications written in C. It provides the core object system used in GNOME, the main loop implementation, and a large set of utility functions for strings and common data structures. It is licensed under the LGPLv2.1 license.
